**A RESOLUTION OF NEW HAVEN TOWNSHIP BOARD MEMBERS AMENDING THE
AMBULANCE ASSESSMENT FEE AND PROVIDING FOR AN EFFECTIVE DATE**

At a meeting of the Township Board for the Township of New Haven, Shiawassee County, Michigan, held on the 12th day of June, 2023, at 7:00 p.m.

Whereas, the New Haven Township Board of Trustees created an ambulance assessment fee to provide ambulance services that are necessary and essential for the health, safety and welfare of the residents of the Township of New Haven; and

Whereas, the Corunna Area Ambulance Service has presented the Corunna Area Ambulance Service Agreement; and

Whereas, the New Haven Township Board of Trustees has determined that the following increase in the ambulance assessment fee is reasonable and necessary.

Now, Therefore, be it resolved by the Board of Trustees of New Haven Township that the ambulance assessment fee that is assessed yearly and collected by the New Haven Township Treasurer shall be as follows:

1. AMBULANCE ASSESSMENT: A special assessment of \$75 per household yearly shall be established for funding the annual assessment for ambulance service.
2. Implementation and Term. The fee set forth in Section 1 above shall be implemented and in effect on June 12, 2023 and shall continue in effect thereafter unless or until amended or modified.

This resolution shall be effective on and after June 12, 2023 and shall replace and supersede any other Ambulance Assessment Resolutions.


